## **USNA Recruiting Update**

It's that time of year again when appointment letters are being sent out to future midshipmen. In the Class of 2020 hopefuls, Minnesota had a total of 73 candidates, 27 of which "triple-Q'd" that is qualified academically, medically and physically. As of this writing, 12 offers have been issued by the Academy as well as one offer to attend NAPS. Seven candidates have accepted to date.

**Q:** What's the best way to recruit for the Naval Academy?

**A:** Have the prospective candidate meet an actual midshipman.

One way to meet a mid is through OPINFO, a program where midshipmen volunteers come home the weekend before Thanksgiving break in order to host information sessions about the Academy in their hometown. Minnesota had nine mids participate in OPINFO last November, including five from the Twin Cities and four out-state.

## A Message from the Chapter President

The USNA Alumni Association – Upper Midwest Chapter has seen a significant transition over the course of the past few years, and I am honored to have been a part of that effort. Our chapter board redrafted a proposed set of new Bylaws, which were unanimously approved by our chapter's voting members, and we've expanded and enhanced our board representation as a result.

We now have not only the Minnesota Parents' Association president as a voting board member, which connects our chapter directly to the Midshipmen from our chapter's four-state region at the Naval Academy, but also with the parents' associations in Iowa, North Dakota, and South Dakota.

We also created board positions for individual state directors to represent the interests of our alumni in Iowa, North Dakota, and South Dakota. Our hope is that we can work with the state directors to craft events and provide other support which will be meaningful to our graduates in those states.

We've also incorporated the Chapter Trustee onto our board, a position we earned as a result of the national association's most recent triennial chapter census, which placed us as the 7<sup>th</sup> largest among all alumni chapters.

Finally, we've created a Blue and Gold Program Liaison Officer position to afford us direct connection with the Naval Academy's recruitment program – something few other chapters have created. In fact, the national association commented on the many initiatives we're pursuing, saying we're on the forefront of very creative thinking with regard to what alumni chapters should stand for, and how we operate.

It is always good to be the organization that is setting the standard for others to emulate!

The Trustee position is one I think we should strive to retain, and to do so, we need to increase our voting membership. Retaining a seat on the National Board of Trustees ensures we can influence what happens at Annapolis, and based on our chapter size - roughly 650 graduates in our four-state region - having such influence is a reasonable expectation. Keeping that seat is but one goal we've outlined in the Strategic Plan which the board just approved and is now on the website.

As the incoming president taking over from Alex Plechash, I'd like to end by taking this opportunity to thank Alex for his unwavering commitment to our chapter's mission and his exemplary leadership over the past eight years. Alex may be leaving the president's position, but he will remain on the board and be a trusted advisor to our new leadership team as we begin implementing our Strategic Plan over the course of the next few years.

I look forward to meeting all of you and I welcome your input at any time on how your chapter board can improve our service to you, to our community, to the Naval Academy, and to our nation.
